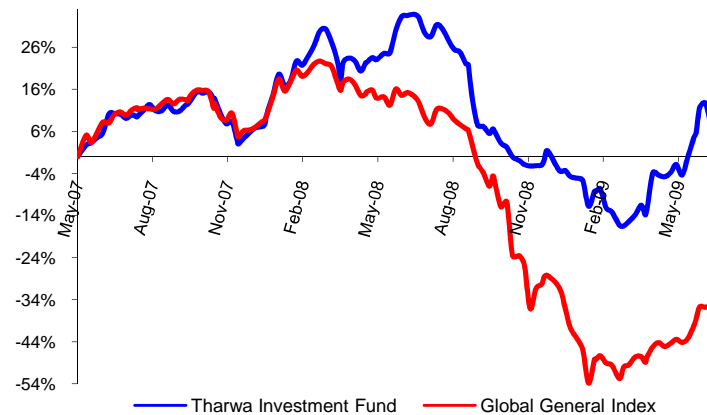

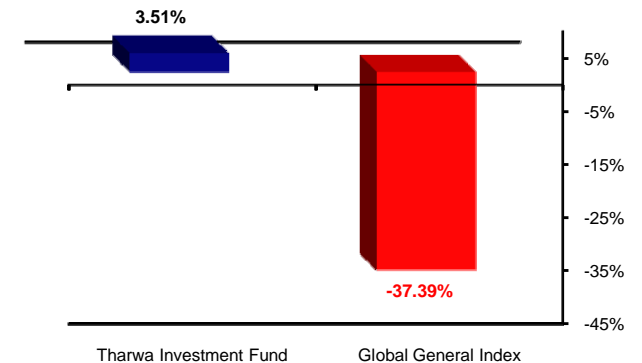

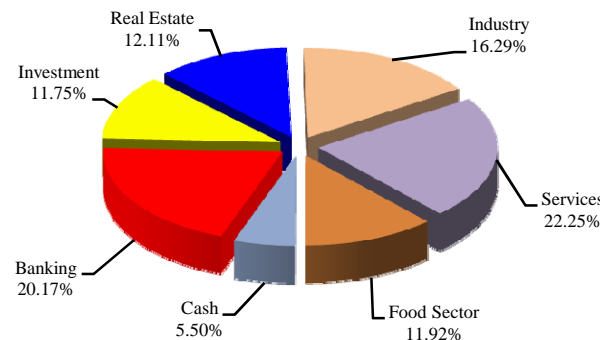
**Fund Cumulative Return Vs. Global General Index**
